TERMS OF REFERENCE FOR THE SUPPLY AND INSTALLATION OF LAN INFRASTRUCTURE AT MAAKE CAMPUS.

INTRODUCTION

Letaba TVET College is looking for service provider to supply and install LAN Infrastructure at Maake Campus.

PROFILE OF THE SERVICE PROVIDER

Any service provider who has capacity to deliver the service as per customer's requirements has the opportunity to bid for this offer.

SCOPE OF WORK

The scope of the project work covers the supply and the installation of LAN Infrastructure Maake Campus situated approximately 30 km from Tzaneen.

- **In scope**
 1. Supply and install LAN Infrastructure for Lab 5.
 2. A thorough test report using a certified cable analyser, to ensure the installation has been performed according to CAT6 guidelines & standards should be provided.
 3. Electrical certification of compliance to be submitted on completion.
 4. Upgrade the electrical DB board to accommodate the new electrical load.
 5. All the cables provided should be Krone or Molex certified.

- **Out of scope**

Supply of any item not listed under the **pricing schedule** list.

- **All goods and services must come with the warranty of three years**

The successful service provider will be expected to enter into an agreement with the College and the funder. The goods and services will be delivered or rendered to Letaba TVET College campuses and payments will be made by the Funder.

EVALUATION CRITERIA

The following evaluation criteria will be utilized to determine a suitable service provider.

There will be a two-stage evaluation process comprising of:

- Stage 1- Prequalification evaluation,
- Stage 2- Price

Stage 1: Prequalification

1. Valid Tax Clearance Certificate.

3. Certified ID copies of all directors/shareholders (Not older than six months)
4. Central Supplier Database (CSD) Registration Report (within one month)
5. Business municipal account or lease agreement or proof of Business address. The business should ensure they are not indebted with the organ of state (Municipal)
6. Fully Completed SBD 1, 4,8 & 9
7. Signed Quotation or Signed Pricing schedule
8. Service Provider must be Krone or Molex certified (attach Krone or Molex certification).
9. Reference letter indicating that your company has successfully completed the project of similar magnitude.
10. Project plan that indicates the timelines.

Stage 2: Price (reasonable price which is market related)

In order to facilitate a transparent selection process that allows equal opportunity to all service providers, Letaba TVET College will adhere to its policy on the appointment of service providers.

BID CONDITIONS

1. Submissions after closing date will not be accepted.
2. No quotes greater than R30 000 will be accepted without a valid TAX CLEARANCE CERTIFICATE.
